The Master: Victoria Russell

Victoria qualified as a solicitor in 1981; she has specialised in construction work throughout her career and is a partner at the specialist construction law practice, Fenwick Elliott. She became a Fellow of the Chartered Institute of Arbitrators in 1991 and earlier this year was elected Fellow of the Chartered Institute of Building. She practises regularly as arbitrator, adjudicator and mediator, serving on a number of panels, in addition to her dispute resolution work as a solicitor.

Victoria is Chairman of the UK Society of Construction Law and was elected President of the European Society of Construction Law in October 2001. She is a former governor of Benenden School and a member of the Exeter University Alumni Board.
